PATIENT AGREEMENT

- New York State law requires that patients obtain a written prescription before initiating treatment by a licensed physical therapist if they are to use their insurance benefits to pay for treatment.
- Patient is responsible to inform BBWPT, PC of any changes in insurance coverage prior to that change. If the
 patient fails to inform BBWPT, PC of a change in insurance coverage, the patient will be held responsible for
 any unpaid claims related to a lapse or change in benefits. This includes MEDICARE patients who are under
 Home Health Care or those who choose a Medicare Advantage plan.
- The patient is responsible for all co-payments and deductibles <u>prior</u> to receiving treatment.
- All visits are by appointment only and generally last about an hour.
- <u>IT IS THE PATIENT'S RESPONSIBILITY TO CONFIRM ALL APPOINTMENTS</u>. Our office sends courtesy text or email reminders. If a patient does not confirm their appointment, our office reserves the right to void their appointment and offer it to a wait listed patient.
